The Living Legacy Fund was established by Odd Fellows Home of California and the SRC Residents' Council as the only tax-exempt charity under OFHC's IRS 501(c)(3) tax exempt umbrella. It's mission "is to generate resources with which to fund the enrichment of the quality of life within and affiliated with SRC". In addition, "the Board of Directors of OFHC has determined that the following uses comply... with the LLF agreement": educational grants, residence assistance and general fund.

In 2018 we awarded 44 Educational Grants for a total of \$107,215 to employees and their children to attend college throughout the United States, with majors from occupational skills to advanced academic degrees.

LLF has received many heart-felt gratitude letters from the recipients of our educational grants. This is a most successful program and we urge SRC residents and families to donate.

Your Gift Matters

The LLF was established in October 2006 for the stated purpose of enhancing the quality of life within, and affiliated with, Saratoga Retirement Community.

Every gift, regardless of amount, is appreciated and applied as the donor desires.

To be sure that all gifts received qualify for a tax deduction, LLF is affiliated with the Odd Fellows Home of California (OFHC), a non-profit organization operating under 501(c)(3) of the Internal Revenue tax code. LLF pays no administrative fees under this arrangement. Assets in LLF are held in an OFHC account managed by Merrill Lynch at the direction of the SRC LLF board.

The Living Legacy Board consists of SRC residents selected by the existing Board and approved by the Resident Council. LLF Board members are all SRC volunteers.



Role of the LLF Board


- Grow the Permanent Fund


Education Grant Summary Grants by Year Since 2008
