In January 2020 the SRC Living Legacy Foundation was confirmed as a tax-exempt charity under the IRS 501(c)(3) tax exempt umbrella. **Tax ID** #84-3432820. Its mission continues: "to generate resources with which to fund the enrichment of the quality of life within and affiliated with SRC." The focus areas for charitable giving are educational grants, resident assistance and the general fund.

In 2019 we awarded 49 Educational Grants for a total of \$110,518 to employees and their children to attend college throughout the United States, with majors from occupational skills to advanced academic degrees.

LLF continues to receive warm gratitude letters from the recipients of our educational grants. This is an investment in our well-being here at SRC and to our community at large. We urge residents to donate. Thank you.







